**ORDER

1. The Minnesota Board of Accountancy ("Board") is authorized, pursuant to Minnesota Statutes section 214.10; Minnesota Statutes section 326A.02, subdivisions 4 and 6 (2016); and Minnesota Statutes section 326A.08, subdivision 1 (2016) to license, regulate, and take appropriate disciplinary action against certified public accountants whenever appropriate.

2. On December 31, 2015, Brenda Faye Keller's ("Respondent") CPA Certificate expired.

3. On November 30, 2017, Respondent submitted a 2016 CPA Certificate renewal application and the appropriate fee for Exempt status to the Board.

3. On April 19, 2018, the Board issued an Order for Automatic Revocation of a CPA Certificate in error, revoking Respondent's Minnesota CPA certificate for failure to renew for more than two years, in accordance with Minnesota Statute 326A.04, subd. 11 (2016).

**NOW, THEREFORE**, based upon the above facts, the Board issues the following:

**ORDER**


Upon consideration of the foregoing and the Stipulation and Order, and based upon all the files, records and proceedings herein, **NOW, THEREFORE, IT IS ORDERED**, pursuant to Minnesota Statutes section 326A.08 (2016), as follows:

A. The revocation of Respondent's CPA Certificate Number 19032 is vacated; and

B. Respondent's CPA Certificate Number 19032 is restored and immediately placed in Exempt status.


