In the Matter of Roger Allen Schanus Certified Public Accountant Certificate Number 05034

ORDER File No. 2018-413

The Minnesota Board of Accountancy is authorized, pursuant to Minnesota Statutes section 214.10; Minnesota Statutes section 326A.02, subdivisions 4 and 6 (2018); and Minnesota Statutes section 326A.08, subdivision 1 (2018) to license, regulate, and take appropriate disciplinary action against certified public accountants whenever appropriate.

FINDINGS OF FACT

- 1. On December 3, 1996, the Board issued an order revoking Respondent Roger Allen Schanus' Minnesota Certified Public Accountant certificate.
 - 2. The 1996 order provides, in pertinent part:
 - Respondent's Certified Public Accountant Certificate is REVOKED.
 - It is further ordered that the revocation shall take effect immediately and shall remain in effect at least until the Board receives a tax clearance certificate from the Minnesota Department of Revenue indicating that Respondent does not owe the State any uncontested delinquent taxes, penalties or interest and has filed all required returns.
 - It is further ordered that this Order may be rescinded by the Board only
 upon receipt of a tax clearance certificate and proof from the
 Respondent that the Respondent meets all requirements for licensure
 and has paid all fees authorizing the Board to rescind this order and
 reinstate Respondent's license.
- 3. On February 8, 2001, the Board received a tax clearance certificate from the Minnesota Department of Revenue.
- 4. On August 9, 2018, the Board received an application for reinstatement of Respondent's CPA certificate.

5. On January 24, 2019, Respondent submitted written documentation of having completed all qualifying continuing professional education credits required by Board statutes and rules that would have been required had Respondent continuously held an active Certified Public Accountant certificate through the proposed date of reinstatement.

6. Based on receipt of the tax clearance certificate from the Minnesota Department of Revenue, the application for reinstatement, and receipt of continuing education credits, Respondent has complied with the conditions listed in the 1996 order.

NOW, THEREFORE, based upon the above facts, all the files, records, and proceedings herein, and pursuant to the 1996 order, the Board issues the following:

ORDER

IT IS HEREBY ORDERED that the Certified Public Accountant certificate of Respondent Roger Allen Schanus, certificate number 05034 is reinstated.
