## **ORDER TO REINSTATE**

The Minnesota Board of Accountancy has determined as follows:

1. The Board is authorized to license and regulate certified public accountants pursuant to Minn. Stat. §§ 326A.01-.14 (2018).

2. The Board issued Murphy a certified public accountant license on April 17, 1990.

3. Murphy's license expired on December 31, 2011, after Murphy failed to file a renewal application.

4. On January 17, 2014, Murphy's certificate was revoked pursuant to Minn. Stat. § 326A.04, subd. 11, after he failed to renew his certificate for more than two years.

5. Murphy contacted the Board in 2019, seeking to have his revoked certificate reinstated pursuant to Minn. Stat. § 306A.09.

6. This matter came before the Board on September 22, 2020, after Murphy and the complaint committee filed written arguments and responses for the Board's consideration.

7. This order is in the public interest.

IT IS HEREBY ORDERED, pursuant to Minn. Stat. §§ 326A.04, .09, that Murphy's certified public accountant license shall be reinstated with an inactive status upon payment of \$495 in fees, consisting of a \$20 reinstatement application fee, \$450 in delinquency fees for the years 2012-2020, and a \$25 inactive-status renewal fee.

IT IS FURTHER ORDERED that if Murphy does not pay all required fees within 90 days, this order shall be automatically vacated and Murphy's license shall not be reinstated.

IT IS FURTHER ORDERED that nothing herein shall be deemed to rescind the Board's order revoking Murphy's certified public accountant license and, moreover, that revocation order and this reinstatement order shall be classified as public data pursuant to Minn. Stat. § 13.41, subd. 5 (2018).
