REINSTATEMENT ORDER

The Minnesota Board of Accountancy has determined as follows:

1. The Board is authorized to license and regulate certified public accountants pursuant to Minn. Stat. §§ 326A.01-.14 (2020).
2. The Board issued Respondent Steven Sloan a certified public accountant license on September 22, 1995.
3. Steven Sloan's certified public accountant certificate expired on December 31, 2016.
4. On April 30, 2019, pursuant to Minn. Stat. § 326A.04, subd. 11, the Board revoked Steven Sloan's certificate because he failed to renew it for more than two years after its expiration.
5. On February 3, 2022, Steven Sloan petitioned to reinstate his revoked certificate pursuant to Minn. Stat. § 326A.09.
6. This order is in the public interest.

IT IS HEREBY ORDERED, pursuant to Minn. Stat. §§ 326A.04, .09, that Steven Sloan's inactive certified public accountant certificate shall be reinstated upon payment of \$325 in fees, consisting of a \$300 delinquency fee, and a \$25 renewal fee.

IT IS FURTHER ORDERED that if Steven Sloan does not pay all required fees within 90 days, this order shall be automatically vacated, and Steven Sloan's certificate shall not be reinstated.

IT IS FURTHER ORDERED that nothing herein shall be deemed to rescind the Board's order revoking Steven Sloan's certified public accountant certificate and, moreover, that revocation order and this reinstatement order shall be classified as public data pursuant to Minn. Stat. § 13.41, subd. 5 (2020).
