- 4) NEW BUSINESS
 - A) Review CPE Rules for Required Changes
 - (1) Review of 2019 CPE Statement on Standards Discussed recommending to full Board incorporating by reference the 2019 version and adding "Content Review" as defined in same to the Board's "Writing" category of CPE.
 - (2) Discuss remedies to Rule "silence" on
 - a. CPE requirements on status change to Exempt and Retired Proposed requirement that anyone changing to Exempt or Retired after June 30 meet the CPE requirements as already defined in Rule in order to make the status change.
 - b. CPE requirements on/path to status change from Retired to Active
 - Proposed path parallel to status change from Exempt to Active, rather than requiring Reinstatement path/issuance of Reinstatement Order
 - Discussed issues raised by language in MN Statute
 326A.045 Subd. 7 allowing for Retired to Inactive status change. Board will need to develop administrative backend for status requirement but also determine if statute should stand or whether no HSW rationale for Retired to Inactive. No Board rule currently exists regarding "reactiving" to a status of "Inactive."
 Reactivation has been specific in Rule to status change to Active only. Discussed time delay between allowing status change from Retired and Inactive, possibly retaining the feature that a status change to Inactive occurs only during a renewal window.
 - c. Repeating CPE courses for credit toward requirements Drafted language prohibiting credit for identical self-study course taken within the same 1-year reporting period.
